A GANG IN LIBYA WAS ARRESTED FOR TORTURING AND BLACKMAILING MIGRANTS, RESULTING IN THE DEATHS OF 10 PEOPLE

The Libyan Public Prosecution ordered the detention of four individuals belonging to a criminal network involved in migrant smuggling and human trafficking in the city of Zella. The Public Prosecutor's Office revealed that the defendants tortured 164 migrants of various nationalities, including Sudanese, Somalis, and Eritreans, resulting in the death of ten of them as a result of brutal torture. The office explained that the arrest took place after the military police stopped a group of migrants fleeing a site where they were subjected to torture and cruel treatment. The accused forced them to pay a ransom of up to \$10,000 under the threat of showing recordings documenting the assaults.

The Internal Revenue Service is approaching The IRS agreement that would allow reached an has immigration officials to access tax data to verify the names and addresses of people suspected of being in the country illegally, according to four people familiar with the matter, The Washington Post reported. This development comes after weeks of negotiations over using the tax system to support US President Donald Trump's plan to deport immigrants on a massive scale. If the agreement is approved, it will represent a fundamental shift in the way federal agencies handle taxpayer data and enforce immigration laws. The Revenue Service has been Internal reassuring undocumented immigrants that their tax information is protected and that they can file their returns without fear of deportation.



VENEZUELA RESUMES REPATRIATION OF ITS MIGRANT CITIZENS FROM THE UNITED STATES



Venezuela announced that it had reached an agreement with the United States to resume the airlift of its migrants from American territory, a week after Venezuelans accused of belonging to a criminal gang were deported to a prison in El Salvador.

FRANCE RESCUES MIGRANTS TRYING TO CROSS THE ENGLISH CHANNEL TO BRITAIN



On Friday, it was announced that 168 migrants were rescued while trying to cross the Channel in small boats to reach Britain. Three migrants were injured and taken to a hospital in Boulogne-sur-Mer, police said in a statement, adding that four rescue operations were carried out off the coasts of Dunkirk and Pas-de-Calais.



A BOAT CARRYING MIGRANTS FROM TUNISIA SANK OFF THE ITALIAN COAST

Six people were killed and 40 others are still missing after a boat heading from Tunisia to the Italian island of Lampedusa sank last Tuesday evening, according to Reuters. For its part, the Italian news agency (ANSA) and local media reported on Wednesday that rescue teams were able to save 10 people, while search operations for possible survivors resumed early in the morning. Media reports indicated that survivors told rescuers that many members of the group, which included 56 migrants, fell into the sea due to bad weather conditions after setting sail from Tunisia.

DOZENS OF AFRICAN MIGRANTS ARRESTED WHILE TRYING TO INFILTRATE ZLITEN



Military forces in western Libya arrested dozens of illegal immigrants of African nationalities as they attempted to infiltrate the city of Zliten. The media office of the General Staff stated on Thursday that the operation was carried out at the behest of the commander of the Central Military Region of the 63rd Infantry Brigade, with forces stationed at the River Gate south of Misrata and the Suwayh Gate south of Zliten.

THREE DEFENDANTS SENTENCED TO 15 YEARS IN PRISON IN A MIGRANT SMUGGLING AND ROBBERY CASE IN AL HOCEIMA

The Criminal Chamber of the Court of Appeal in Al Hoceima issued a five-year prison sentence in absentia for each of three defendants, for their involvement in organizing and facilitating the illegal immigration of Moroccan citizens, as well as their participation in secret agreements to smuggle people out of the country illegally. The ruling also included convictions for aggravated theft.. This decision came after an in absentia trial of the defendants, who were absent from the court sessions, with the completion of all necessary legal procedures.





THE JUFRA SECURITY DIRECTORATE DISMANTLED A GANG INVOLVED IN TORTURING AND BLACKMAILING ILLEGAL IMMIGRANTS

The Al-Jufra Security Directorate announced the arrest of a criminal gang involved in torturing, abusing, killing, and raping illegal immigrants, with the aim of blackmailing them and forcing their families to pay huge ransoms in exchange for their release. The directorate stated, in an official statement issued on Tuesday, that the security operation resulted in the release of 82 migrants who were being held by the gang, without revealing the number of those arrested so far, stressing the continuation of efforts to pursue the remaining members of the network involved in these crimes.




RAID ON A MIGRANT DETENTION SITE IN SABHA

The latest controversy was sparked by the increasing number of migrants arriving from the Sahel and sub-Saharan Africa, for whom Mauritania was merely a transit point toward the continent of dreams. New factors changed this reality, transforming the country into a final destination for some. Dimensions of controversy. On March 7, 2024, Mauritania concluded an agreement with the European Union on irregular migration, under which it will receive funding exceeding 80 billion ouguiyas more than 200 million euros, in exchange for taking measures to limit the flow of African migrants towards Europe.
